I. Welcome, Introductions:

Ms. Debra Johnson asked for everyone in the room to introduce themselves and state where they are from.

II. Agenda Changes: No agenda changes at this time

III. Acceptance of May 2022 Meeting Minutes:

Ms. Debra Johnson asked if there were any corrections or additions to the May CSCB Full Body meeting minutes. Ms. Kathy Sawntek moved to approve the minutes, seconded by Ms. Melinda Johnson. **MOTION CARRIED**

IV. Organizational Presentation Offender Success

Mr. Robert Esselink gave a brief presentation on the Offender Success Program in Region 6. He shared the mission and vison statements. He explained the Offender Success Reentry Model and how it benefits individuals once they are released from prison. Mr. Esselink noted there are five staff members that work in the region and the different services that can be provided: such as Residential Stability, Job Placement, Social Support Services, and Behavioral Health Services. Offender Success provides 24/7 structured housing along with base housing. Catholic Charities of Shiawassee and Genesee Counties was awarded the contract to manage this program when MI Works, Macomb and St. Clair County no longer wanted to. This change occurred earlier this year.

V. Emerging Issues

A. August Millage Requests

a. Council on Aging

Mr. Scott Crawford explained that 1.2 million meals have been distributed, along with 183,000 rides to various locations for local seniors. He stated that the current senior citizens millage rate is .7983, which is a 4-year renewal beginning 2022-2025. Since this is not a new millage but a renewal, taxes will not increase. He noted the different services that the millage provided in 2018-2021.

b. SCC Library

Ms. Allison Arnold explained that the Library's request is a new \$1.2Million millage. This would provided increased services for all 11 public libraries that serve residents of St. Clair County. She explained that property taxes fund approximately 76% of the public library operations, and that the county library system would not be able to continue to stay open without this millage.

c. SC4

Ms. Bonnie DiNardo explained that St. Clair Community College (SC4) is asking for a renewal of \$1.5 Million millage. She stated this would not increase the tax rate, and that this millage is crucial to the college's budget and ability to meet students and community needs.

B. Breast & Cervical Cancer Control Navigation Program

Ms. Mitzi Koroleski explained that the Breast & Cervical Cancer Contol Navigation Program (BC3NP) provides free breast and cervical cancer screening services to women who are 40-64 years old, uninsured or underinsures and meet the income guidelines. Mammograms, Pap/HPV, and Breast and Pelvis exams are offered as well. There were handouts in the packet with more information and contact information.

C. Community First Health Mobile Unit

Ms. Sarah Gilstrof gave a brief overview of the Mobile Medical Unit. She stated that it offers individuals primary care services, health screenings, health education and includes vaccine clinics.

a. Housing Workgroup

Ms. Kathy Swantek reminded each member that there is a housing summit on Tuesday, November 15, 2022 at 8:30-12:00pm. She noted this event cost \$25.00 and will have Dr. Matthew Desmond, PhD, as the keynote speaker. She encouraged everyone to read Dr. Desmond's book, "Evicted" and to attend the Housing Summit. She also stated that in order to pay for the Summit, the committee is asking for sponsors. If anyone would be interested in being a sponsor for this event, the information was included in the meeting packet.

b. Substance Use Disorder PTR

c. Adolescent Services

Ms. Karen Palka noted the group is currently in the process of linking with different organizations in the community to help promote the Adolescent Services Resource Guide through the QR code. Ms. Palka also stated the group is also trying to find ways for members to continue to participate.

Ms. Riley Alley announced there will be a story walk ribbon-cutting on July 28th, 2022 from 2:00-3:300pm at Fort Gratiot County Park.
